

BROOKWOOD HILLS COMMUNITY CLUB, INC.
TENNIS REGULATIONS – 11/2018

ONLY CURRENT “A”, “C”, and “S” MEMBERS ARE PERMITTED TO USE THE BROOKWOOD HILLS COMMUNITY CLUB (“BWHCC”) Tennis Courts (the “Tennis Courts”, “Tennis”, “Courts”, “Facilities”). ALL CURRENT MEMBERS ARE RESPONSIBLE FOR ORIENTING THEMSELVES WITH THE CURRENT RULES. EACH MEMBER, UPON ANNUAL PAYMENT OF DUES, ACKNOWLEDGES THAT THEY HAVE READ, AND WILL ABIDE BY, THE RULES AND REGULATIONS OF THE TENNIS COURTS.

FAILURE OF MEMBERS OR THEIR GUESTS TO FOLLOW THE RULES AND REGULATIONS, VERBAL INSTRUCTIONS OR WARNINGS FROM BWHCC, INCLUDING BUT NOT LIMITED TO: DIRECTORS OF THE BOARD OF BWHCC, OR OTHER PERSON EMPLOYED BY THE CLUB ASSIGNED WITH THE RESPONSIBILITY OF MAKING THE TENNIS FACILITIES AND COURTS A FUN AND SAFE PLACE FOR ALL MEMBERS MAY RESULT IN ANY OR ALL OF THE FOLLOWING DISCIPLINARY ACTION: FINE(S), TEMPORARY OR PERMANENT EXPULSION FROM THE TENNIS FACILITIES, TEMPORARY OR PERMANENT REVOCATION OF CLUB MEMBERSHIP.

MEMBERS MAY NOT ENTER THE TENNIS AREA WHEN THE TENNIS AREA IS CLOSED.

ADMITTANCE - MEMBERS & GUESTS

BHCC reserves the right to refuse admittance of any person to its facilities.

General:

1. Consistent with BWHCC By-laws, BWHCC operates facilities for the social and recreational benefit of its Members.
2. The tennis facility is for use by BWHCC Members and their accompanied guests only.
3. BWHCC Members shall have priority with respect to scheduling and use of the courts.
4. Absolutely no pets allowed on tennis courts or at court level viewing areas including walkways and stairs adjacent to the courts, basketball courts, walkway adjacent to the concession stand, pool deck.
5. Court hours are from 7:00 am to 10:00 pm.
6. Food is not permitted on the courts. All paper cups, plastic water bottles, and other litter must be removed and disposed of by the players when leaving the court area.
7. All people who are not actively playing tennis, or receiving tennis instruction are not permitted on the courts.
8. Members must play in tennis shoes. Playing in street shoes or in bare feet is not permitted.

9. Skateboards, scooters, roller skates, roller blades, bicycles, tricycles, and other wheeled vehicles are not allowed on the courts.
10. The court divider should not be moved or pulled back except when doubles matches are being played on one or both of the courts.
11. Lights must be turned off at the end of play, no later than 10PM. The light switch is next to the telephone and tennis bathroom.
12. In situations not covered above, the spirit and general intent of the regulations govern. The courts should be available to as many Members as possible.

Reservations:

13. Members may reserve courts 7 days before the scheduled use. The maximum time slot reservation (FOR NON-LEAGUE PLAY) per day is ninety (90) minutes.
Reservations should be made online at brookwoodhills.com.
14. Members may reserve a court for themselves or immediate family only.
15. Members unable to play must cancel their reservation at least two (2) hours before the period reserved. Violators of this regulation will have their names posted.
16. Persistent violators of the reservation cancellations policy will be subject to additional penalties or restricted from continued use of the reservation system. Parents are responsible for their children's reservations.
17. Court reservations are valid up to fifteen (15) minutes past the commencement of the reserved time period. After the fifteen (15) minute grace period, the court will be forfeited.
18. Children under thirteen (13) years of age may not use or reserve a court without an adult or caregiver (aged 16 or older) present.
19. Members should not play more than one 90-minute period per day and may not make an individual reservation to extend League Play hours.
20. Players or groups must vacate the courts after one 90-minute period when other Members are waiting to play. Members may use unreserved or unclaimed courts.

Guests:

21. Guest fees are \$10 per Guest for each 90-minute maximum reservation block. Guest fees are not pro-rated for play lasting less than 90 minutes.
22. Guest fees must be paid at the time the reservation is made on www.brookwoodhills.com
23. Members who do not honor the requirement to pay Guest fees shall be subject to: being billed, being restricted from making reservations, being restricted from the tennis facilities, and having Club Membership revoked (as determined by a majority vote of the Board of Directors).
24. Guest fees associated with forfeited courts will not be refunded or credited.
25. Guests must be accompanied by an "A", "C", or "S" Member in good standing, while present at BWHCC Facilities.

LESSONS:

26. BWHCC, at its sole discretion, may engage and permit qualified professional instructor(s) to provide lessons on BWHCC Courts to the Membership for a fee.
27. Members who wish to arrange lessons independently from those offered through the professional instructor(s) offered by BWHCC shall make reservations and pay guest fees for such lessons and professional instructor(s) as required.
28. BWHCC Board of Directors will determine, at its sole discretion, when Lessons from the professional instructor(s) it engages shall be offered.
29. There shall be no Lessons on Holidays or Weekends unless approved in advance by the BWHCC Board of Directors. Requests for approval should be made to the BWHCC Pool and Courts Chairperson(s).
30. **Guests may participate in lessons or clinics when accompanied by a Member AND Guest fees have been paid (fees for lessons or clinics do not include mandatory guest fees.)**

LEAGUE PLAY / PRACTICE:

(League Play includes: ALTA, USTA, T2, ULTIMATE TENNIS)

31. Consistent with BWHCC Regulations, BWHCC, at its sole discretion, *may* extend an invitation to host one (1) Weekday Team, and one (1) Weekend Team per “season” as determined by BWHCC. For clarification there are four (4) Tennis Seasons: Fall, Winter, Spring, Summer.
32. Guest fees and the 90 minute per day court time rule are waived for team players using the tennis court facilities during scheduled League events.
33. As of 1/1/2019 no NON-BWHCC members may be listed on the League roster or play on a BWHCC League team.
34. The BWHCC Board will extend League play invitations to Teams 6 months prior to the start of the Season. Example: September for Spring play. March for the Fall Season
35. To be considered by BWHCC for use of the BWHCC Courts, League teams must apply to BWHCC and provide the following information for each “season” for which they wish to be considered:
 - a. Must be 100% BWHCC Members
 - b. Have as captain or co-captain of the team, a current BWHCC Member in good standing.
 - c. Provide the following Team information: Team Roster, season start and end dates, time(s) of day, requested practice day/time. When the League match play schedule is available (typically 4 weeks prior to season start) Captains must submit this to the BWHCC Tennis Chair. The Board will consider this information when considering its decision to extend an invitation to host a team. **THE BWHCC TENNIS CHAIR WILL MAKE ALL LEAGUE PLAY RESERVATIONS.**
36. There shall be no League events on the courts on holidays or weekends unless approved in advance by the BWHCC Board of Directors. Requests for approval should be made to the BWHCC Pool and Courts Chairperson(s).
37. BWHCC Board of Directors shall determine, at its sole discretion, when League events (practice, matches, tournaments, etc.) may be scheduled.
