

# THIRD ANNUAL MULCHING IN THE PARK

(Editors note: This year, rather than running the success story of our Christmas tree mulching project after the fact, it seemed appropriate to feature it this month and encourage all neighbors to participate.)

Arborguard Tree Specialists has agreed to mulch our Christmas trees for what is becoming a wonderful



neighborhood tradition. The recycling effort is a great way for the neighborhood to benefit from our Christmas trees, rather than just placing them in a landfill.

This project began in 1997 when neighbor Cookie Frank noticed that Christmas trees seemed to linger longer and longer on the curbs every year. Cookie and friend/neighbor Carla Fackler decided to do something about it. Both ladies are quick to point out, however, that it was the cooperative efforts of the whole Brookwood Hills community that really made it happen. In the first year, neighbors pitched in picking up trees from other neighbor's curbs, making signs, and calling for volunteers to help the day of the mulching. "We

are a community and we work together to get things done" says Cookie, a 26 year resident of Camden. In January of 1998 we mulched 150 trees, the following year that number jumped to 250 trees! Again, it was neighbors who made the difference, bringing trees to the park that had been left out on the curbs and letting neighbors know about the mulching program.

This year we hope that even more neighbors will bring their own trees down to the park. It is a won-derful family project that reminds us all of the value of recycling. The children will see that something they have enjoyed so much during the holidays can also be a part of their park or yard in the form of mulch all year long.

#### SPEED HUMPS – a letter from the Presidents

Recently, each of you received a letter asking support for a petition to delay the installation of speed humps on Huntington Road and Brighton Road until a traffic evaluation of the neighborhood could be conducted. The letter was drafted by a group of concerned residents on Palisades Road, although some neighbors erroneously assumed that it had been distributed by authority of the Board of Directors. While the Board has met with the Palisades residents to discuss their concerns, it has not endorsed either a delay or a termination of the speed humps. In order to provide the neighborhood with a greater understanding of the actions leading to the current controversy, we have joined, as presidents of the Board, to write this letter.

The problem of speeding in the neighborhood is a long-standing one, and had been discussed at Board meetings annually since the 1960s. Self-monitoring had not proved effective. In the spring of 1997, then president Betsy Crosby received two requests from neighbors asking that the problem of speeding on Huntington Road and Brighton Road be addressed by the Board. At the May and June '97 Board meetings, the Board discussed numerous options for resolving this problem, including speed humps, stop signs, ticketing, and 25 mph signs. Requests to the City from previous BWH presidents for more stop signs and more police officers to monitor speeding traffic had not been successful. The Board determined that speed humps might be a promising solution to the speeding problem.

Mayor Campbell had initiated the speed hump program in 1997. For the first time in the City's history, the program allowed changes to the configuration of residential city streets for traffic control. The humps were required to follow a specific format, and City representatives gave no indication that any other street designs would be permitted.


As directed by the Board, Betsy Crosby wrote the City requesting that all BWH streets be evaluated for speed humps. Additionally, she made a written request to the City for more stop signs, which was denied. During the summer and fall of 1997, our streets were evaluated by the City, with only Huntington Road and Brighton Road meeting the City's criteria for speed hump installation. Neighbors on Huntington and Brighton volunteered to gather the necessary approval signatures from 75% of the residents of their respective streets. These signatures were submitted to the City and approval for installation of speed humps was granted early in 1998.

On several occasions, Brookwood Hills residents were invited to comment on speed humps. Specifically, the May '97 Brooknotes asked for comments pro and con from the neighbors and invited them to attend the next Board meeting. Before signature gathering for Huntington Road began, a second article appeared in the September '97 Brooknotes discussing the appearance of the proposed humps and inviting comment from the neighbors. No objections were addressed to the Board on either occasion. Finally, outgoing president Betsy Crosby gave a status report on speed humps at the Annual meeting in January, 1998, where special guest Councilman Lee Morris addressed his support for the program.

Although the City has pushed back the installation of speed humps on Huntington and Brighton Road a number of times, the humps are currently slated to be installed in February or March of 2000. A notice of the pending installation of speed humps in the October Brooknotes prompted the concerned residents to circulate their request for delay. At the December Board meeting, the Palisades residents voiced their concern and reported that they had collected over 100 signatures in support of a delay of installation.

The City of Atlanta considers the petition to install speed humps by the residents on Brighton and Huntington to be a mandate from the individual residents and not one from the Board of Directors of the Brookwood Hills Community Club. It is unclear at this time whether the Board has any further input on this issue, and the Board has not voted to take any action. In view of the number of residents that appear to support a delay, representatives of the Board are planning to meet with Lee Morris, our City Councilman, and Sandra Jennings (who runs the City's Streets & Highways Division) in order to explore what alternatives, if any, are available to the Board, the neighborhood, and the streets in question.

The Board will communicate all relevant information as quickly as possible to all residents of the neighborhood on this and all issues of concern. It is vitally important that you read all communications and act on requests for comment promptly.

Please remove all metal debris (tinsel) and tree lights before bringing the trees for recycling.
