# A Holiday Gift from Atlanta Police Chief Richard Pennington

As reported in Thursday's City Life section of the Atlanta Journal Constitution, last week, the Atlanta Police Department teamed derground Atlanta at Peachtree Street from up with MARTA police to create a joint holiday deployment plan to put more than 100 additional uniformed officers on the streets. The plan also calls for increased police presence in and around MARTA stations and at shopping malls.

"The city has to be safe during the holidays." Atlanta Police Chief Richard Pennington said.

That is music to the ears of businesses. Holidays traditionally have been times for increases in certain crimes, particularly theft.

Pennington said officers will patrol areas that usually show crime increases during the holidays, such as shopping centers and high traffic areas along Peachtree Street.

According to the plan, 20 Atlanta detectives will put on their uniforms and patrol Peachtree from Marietta Street to Baker Street. from 10 a.m. until 6 p.m. daily; 54 police recruits will patrol Peachtree from North Avenue to Collier Road from 2 until 10 p.m. daily; 30 retired police officers and MARTA officers also will join the patrol, with the retired officers patrolling shopping centers.



Also, six to eight MARTA officers will be deployed from 2 until 10 p.m. daily near Un-Alabama Street to Marietta Street.

Wilson said his department also will beef up protection at its downtown stations and increase patrols of parking lots.

Pennington said simply the presence of an increased number of officers should deter crime but added that patrols will actively pursue criminals and make arrests. On some stretches of Peachtree Street, he said, you should not be able to walk two blocks without seeing a police officer.

"We will be out there and visible," Pennington said.

# Allied Readymix Applies to Operate in the Armour Circle Industrial Area

As many of you have by now heard, Allied Readymix intends to locate a concrete batch plant in the Armour Circle industrial area. Their proposed location abuts the woodlands that are owned by our neighborhood behind the far end of Camden. In order to locate their batch plant in Armour Circle, Allied has asked the City for a special use permit and a rezoning of the property from I-1  $\,$ (light industrial) to I-2 (heavy industrial). At it's November and December meetings, the Community Club Board voted unanimously to oppose the rezoning and special use applications. In addition to having serious concerns about noise, appearance, and environmental impact, the board believes that allowing any I-2 business to operate in Armour Circle sets a bad precedent. The Peachtree Heights Civic Association and many of the current Armour Circle tenants also oppose Allied's applications. On December 4, NPU-E (the neighborhood planning unit to which BWH belongs) voted unanimously against Allied's applications. The City's Zoning Review Board nevertheless has now voted in Allied's favor. Their applications will next be considered by the City Council's Zoning Committee, and then by the full Council in January.

In the meantime, our NPU representatives, Jill

Perkey and Lauren Monroe, have spent many hours on this matter, as has Kathy Zickert, a zoning attorney who serendipitously (from our perspective, though perhaps not hers) moved into BWH three weeks before we discovered Allied's plans. Among other things, they toured one of Allied's newer plants to try and understand the technology that Allied will be using to minimize environmental effects. They also, with Allied's cooperation, conducted a visibility study that indicates that we will not be able to see the plant, assuming the tree coverage on our Clear Creek property remains healthy. The board has now hired an independent sound engineer to model the noise impact the plant will have, and we are in the process of locating an expert on the environmental effects of concrete batch plants. In addition, Howard Shook, our City Council representative, has been monitoring the situation and has been very supportive.

We will continue to update everyone as the situation develops. Please feel free to call or e-mail me if you have additional questions about this matter or would like to volunteer to help.


