

# **BWH Annual Meeting and Elections**

The BWH Community Club held its annual meeting on Sunday, January 23<sup>rd</sup> in Rich Auditorium. Outgoing President Roy Trimble provided an overview of the year's events and accomplishments. These included many neighborhood improvements such as resumption of the tree planting program, extensive water drainage management measures in the pool and park areas, and painting of white lines at all street intersections to improve traffic safety.

Roy thanked the outgoing board members for their service to the neighborhood: Dan Bromstad, Wendy Silliman, Amy Mattingly, Maureen Zent, Mark Potts, Katie Simon and Bill Kantola. Barry Miller was also thanked for 25 years of service to our neighborhood. A motion was made to accept the new board of directors and was unanimously endorsed.

Nicole Cook presented information concerning the Clear Creek easement negotiations with the city. The BWH committee is in ongoing negotiations concerning the possible purchase, by the city, of a conservation easement on the property. There was much discussion concerning how this will affect the neighborhood, the possible purchase price and what would be done with that money if the purchase occurs. Street meetings are planned for the near future to discuss these issues in order for the board to get an idea of the neighborhood views.

After welcoming new Community Club President Scott Bass the meeting was adjourned.

## Letter from the President

Our current goal is to hold a neighborhood meeting in March or April to address the concerns and questions of everyone in the neighborhood. The board will then vote on the issue later in the spring. We will notify the neighborhood as soon as a date has been determined for this meeting.


