NPU-E Supports The Brookwood Hills Stance On The Beltline

On February 3rd Neighborhood Planning Unit E unanimously supported Brookwood Hills in its efforts to protect the environment of our Clear Creek Conservation Area by incorporating a key condition in its approval of the December 2008 "Atlanta Beltline Master Plan for the Peachtree Northside Piedmont Segment," technically known as Subarea 7 (SA7). The vote followed a month of final consideration by various community groups of the Master Plan document initially presented to the NPU in January. More importantly, it represented the positive impact of 4+ years of intensive involvement by Rod Cook and Alex Summers representing the interests of Brookwood Hills in the Beltline planning process. Eve Goldstein and Jerry Luxemburger have also spent many hours working behind the scenes.

At stake in the Master Plan is the routing of the Beltline Trail and the potentially harmful environmental impacts on the Clear Creek Property currently protected under the Conservation Easement granted to the City. The all important condition of the approval establishes for the record a carefully worded "Statement of Support" approved by the Board of Directors of the Brookwood Hills Community Club, Inc. on February 2nd and submitted to NPU-E the following evening:

Brookwood Hills has consistently supported the Atlanta BeltLine Transit and Trail concept since it was introduced in 2004. Under the BeltLine Master Plan, dated December 2008, Brookwood Hills strongly supports Beltline Trail Option #1 (green line). Brookwood Hills has and continues to strongly oppose Trail Option #2 (red line) and Trail Option #3 (blue line) which would have significant negative environmental impacts primarily on the Clear Creek greenspace which is permanently preserved by a conservation easement with the City of Atlanta, as well as other areas owned by Brookwood Hills.

Prior to the Board's approval of the "Statement" the matter was discussed at the January 11th Annual Meeting. The "Statement" clarifies the neighborhood's position on the Trail Options as noted in the Brookwood Hills Long Range Plan and corrects an error contained in the Beltline SA7 Master Plan document itself regarding BWH's stance on one of the trail options. Those attending the NPU-E meeting on behalf of Brookwood Hills included current Community Club President John Mulcahy, and four former presidents, Alex Summers, Jim Stokes, Rod Cook, and Joe Gardner, who is currently the NPU representative. Councilperson Howard Shook, representing District 7 (which includes Brookwood Hills), was instrumental in requiring NPU review and approval of all segments of the Beltline Master Plan so as to ensure community input to the City Council as it considers approval of the plan.

Sanitation Pick-up Calendar

As of January 5th the City of Atlanta has changed its schedule for collecting solid waste. While "regular garbage" continues to be collected every Monday as usual, pick up of yard trimmings and recycled materials now occurs on an every-other-week schedule. The system has been in place over a month now, but quite a few fully loaded recycle bins are still being left out on the street on the "wrong" week, sometimes resulting in newspapers, plastic bottles, and so on blowing onto yards and side-It hasn't helped that much of the neighborhood never received the calendars that were supposed to be both mailed and hand-delivered to all customers. Here is the schedule for the remainder of 2009:




Cut this out and post it where you can refer to it during the year.

Brighton Road Misses "Miss Nancy"

Brighton Road lost Miss Nancy Keeler Rhodes on December 28th at the age of 96. An original resident of 82 Brighton, "Miss Nancy" was a wonderful neighbor and friend who will be dearly missed. Her parents built 82 Brighton around 1925, so Nancy Keeler was in her early teens when she moved there. When we moved in across the street in 1993 she regaled us with tales about the builders, architects and successive owners of every house on upper Brighton. What stories she could tell! A wry smile and a tilt of the head and you understood a little more.

Our family loved to visit Miss Nancy for a ginger beer, a story or two, and a look at her photo albums. She often spent Halloween and Christmas Eve with us, enjoying the children and a glass of wine or eggnog. As the niece of O.B. Keeler (the writer who traveled with Bobby Jones for many years), she observed Atlanta through very interesting times, which she clearly relished. She was married briefly, widowed from "Dusty" in the late fifties, and had no children. She never remarried and lived at 82 Brighton until a couple of years ago when she finally had to move to St. Anne's Terrace after a fall.

I'm not sure of the chronology but among a long list of accomplishments she taught dance to young girls, worked for the USO during WWII and got to drive Bob Hope around town, was a bridal director for Rich's, instructed over 800 debutantes in protocol at the Phoenix Society, and taught a course called "Gracious Living" at Westminster. That was the course she never stopped teaching.

Miss Nancy preached "circulation" as the key to her longevity, and she started each day with a little exercise. We all loved having this "extra grandmother" on our street.

Brookwood Hills Neighborhood Spotlight: Judy Simmermon

- Q. You have a PhD in Psychology tell me about your practice.

 Judy: I started out as a school psychologist and then went back for my PhD with a specialization in educational assessment.
- Q. What does that mean? Judy: I specialize in diagnostic testing and assessment to determine what is interfering with a child's success in school.
- Q. Has testing changed over the years? Judy: There have been tremendous changes. Research has yielded significant strides in the understanding of brain function. Better testing makes it possible to pinpoint processing issues.
- Q. Is it easier to test and diagnose a five year old than a nine year old? Judy: Clearly, it is much easier to test a nine year old many of the variables associated with development are removed. With a five year old, you have to use a great deal of clinical judgment to arrive at accurate assessments. The expertise and experience of the clinician is terribly important. But, early assessment is critical. By nine, you have wasted precious years to intervene. The brain is so malleable in the early years that early intervention can make all of the difference in the world. In addition, by nine a child with learning difficulties often has painful wounds to self-esteem.
- Q. Are teachers normally the first to suggest testing?

 Judy: Often that is the case but parents with an older child may be proactive. Parents are much more aware these days of learning issues. Sometimes parents are too anxious, but testing can give them comfort. Often a parent's instincts are correct and we can take action.
- Q. And you help identify appropriate schools for your clients?

 Judy: I do know a great deal about the schools offering remediation for learning differences.
- Q. What general advice would you give parents about selecting schools for their children? Judy: There are so many factors to consider, but most important is to match the spirit of the child to the spirit of the school. Clearly, the educational environment must be good, but you need to consider factors such as the competitive environment, and whether or not the school is a good match with your child's passions (sports, theater, music for example). I have identical twin daughters. One went to a private school in the city and one went to a public school in DeKalb County. They had identical SAT scores and were admitted to the same colleges though their high schools were quite different. My daughters had different temperaments and thrived in different environments. You just need to find a good fit with your child.
- Q. And what are your daughters doing now? Judy: Julie is an attorney with Georgia Pacific and Jill is a consultant with Bearing Point. She is working on a project for the CDC in developing an ethics fellowship.

- Q. When did you move to Brookwood Hills and how did you pick the neighborhood? Judy: We moved to Montclair Drive around 1991. My husband Bob and I are both from the Midwest (Illinois and Indiana) and the sidewalks and houses reminded us of our hometowns.
- Q. And Bob is a psychologist and playwright? Judy: Yes, Bob is a psycho-therapist in private practice working with adults and couples and he has had some of his plays produced. He is very creative he also does some media consulting, on documentaries for example.
- Q. Are the two of you finding people with higher levels of stress and pressure? Judy: Absolutely. People are worried like they never have been worried. They need therapy the most when they can afford it the least. I just tell people to hang on.
- Q. How do you deal with stress? Hobbies? Judy: I knit! I am not very good yet but I find it very meditative. I love to travel, cook and am an avid reader.
- Q. What have you read recently? Judy: I really enjoyed Julie and Julia, My Year of Cooking Dangerously by Julie Powell. It is about a woman who cooked every recipe in Julia Child's Mastering the Art of French Cooking. I found myself laughing out loud.

Author's note: I hope to find a cheese soufflé on my doorstep!

Thanks to everyone for keeping their dogs leashed during this time, because in the past there have been instances of dogs springing the traps. We have had zero such occurrences this time around.

According to John, there may be more coyotes roaming the Clear Creek area so we will continue to trap for the next week or two. Please continue to keep your dogs leashed and monitor your outdoor pets during this time. If you happen to sight a coyote in the neighborhood, please make sure to notify me via the website. We will continue to trap as long as the coyotes roam the neighborhood and nearby area.
