FIELD OF DREAMS PROJECT IS IN PROGRESS

Dear Brookwood Hills Friends,

We appreciate your enthusiastic response to our fund raising campaign last fall, and we would like to update you on our progress.

Thanks to supporters like many of you, we are well on our way of reaching our goal of \$150,000. Through generous support from the business community, neighbors, alumni and friends, we have succeeded in raising \$100,000! In addition, we have applied to a few local foundations for further financial support and are awaiting their decisions.

This money will go towards a track, infield irrigation, a new playground and other aesthetics. General maintenance and drainage work will be completed by the Atlanta Public School System (APS). APS has contracted with Beers Construction for their portion of the work. We are happy to report that the construction permit has been issued by the city and Beers began work in late May. It is estimated that the work will take 75 days to complete.

Meanwhile, the City of Atlanta has plans to renovate the sewer system within the Rivers Road Basin, which includes sewer work under the E. Rivers athletic field. The city has contracted with Montgomery Watson, an independent contractor for this phase of the project.

Once again, we thank you for the endorsements you have given to our project. As alumni and current family members, E. Rivers school means a great deal to many of you. As neighbors, your support goes a long way in enhancing your neighborhood school, and as friends, your generosity is heartwarming. BWH BOARD ESTABLISHES TREE PROTECTION POLICY

At its June Board Meeting, the Brookwood Hills Board of Directors voted to establish a policy to help prevent the premature loss of the neighborhood's large trees. Many of our trees have died or are in a state of serious decline because of the impact of construction projects that have occurred in close proximity to those trees. Many of those construction projects have been undertaken by residents who require additional living space and would rather stay in the neighborhood and enlarge their current homes than leave and go elsewhere. This is a wonderful testament to Brookwood Hills and the quality of life here that we all value and enjoy. Maintaining that quality of life, however, depends in large part on our ability to sustain the trees that provide us with cleaner air, shade and a peaceful retreat from the hustle and bustle of our rapidly developing city. Although a tree must occasionally be sacrificed to make room for building, in far too many instances valuable trees have been needlessly sacrificed when some careful advance planning and oversight of how those plans are executed would probably have saved them. The needless sacrifice of those trees not only hurts the neighborhood; it subjects the homeowner and any relevant contractor to the penalty provisions of the city's tree protection ordinance, which the city is beginning to enforce more vigorously. The penalties for the unlawful destruction or removal of a tree under the city ordinance include substantial fines. Violators may also be required to replace the lost trees on an inchfor-inch basis.

In light of the foregoing, the Board has adopted the following policy to help make residents more aware of the rules already in place to protect trees and to further the goal of maintaining the tree canopy and urban forest that are so essential to Brookwood Hills:

All residents of Brookwood Hills are expected to protect and maintain the trees on and adjacent to their property during any building or other construction project, in accordance with the City of Atlanta ordinance, Section 158-28, which provides that "no person shall directly or indirectly remove or destroy any tree having a diameter at breast height (DBH) of six inches or more... without first obtaining a permit...." The term "destroy" is defined in the ordinance as meaning "any intentional or negligent act which will cause a tree to die within a period of two years including, but not limited to, cutting the trunk, roots or other vital sections of the tree, damage inflicted upon the root system of a tree by the application of toxic substances, damage caused by the operation of heavy machinery, [and] the change of natural grade by excavation or filling of the cover area...."

In furtherance of the City of Atlanta's policy, as set forth in the tree protection ordinance, that "there shall be no net loss of trees...", any resident who destroys or removes a tree in violation of the ordinance shall be asked to replace such tree with a new tree of a similar variety, with a diameter at breast height of no less than 2 ½-3½ inches, either on that resident's tree lawn or front lawn, if conditions are suitable for planting there or, if not, then at another location in Brookwood Hills identified by the BWH Tree Committee.

Please note that the most important step to take in protecting trees from construction projects is the erection of a fence around the tree. Contrary to common perception, however, the purpose of the fence is not merely to protect the trunk and the structural roots of a tree. If a mature tree is to have any likelihood of surviving a construction project, most, if not all of a tree's <u>critical root zone</u>, upon which the tree depends for absorption of water and nutrients, and which extends <u>all the way out to the perimeter of the tree's leafy canopy</u>, must be protected from disruptions such as trenching, storage of heavy equipment and materials, and the movement of heavy vehicles. The fence should be erected prior to any land disturbance, demolition or construction, and should remain upright until final land-scaping requires its removal. If you are planning to undertake a construction project, please contact the City Arborist, Frank Mobley, at 404-330-6150, to ensure that you have taken adequate steps to protect your trees, or call the Tree Committee Chairman, Nancy Field, who will be happy to assist you. Additionally, if you are aware that someone is planning a building project in the neighborhood who may be uninformed about the city's tree ordinance and the neighborhood's tree protection policy, please let Nancy know.


