Up In Smoke

Sara Jean and Fred Burke were entertaining out of town guests the evening of Friday. March 8, when they saw the smoke and heard the sirens of the fire trucks racing to the home of Anne and Bradley Hale at 61 Brighton Road. "Let's go watch the fire," said the son of one of the guests. "This is a once in a lifetime opportunity."


If only it were true. Twice in one month, three times in the last two and a half years, homes in Brookwood have

suffered destructive fires. As we gather on the sidewalk and watch helplessly, we can't help wonder, "Can't the firemen work faster? Why does it take so long to put out a fire?"

Five firemen from the Atlanta Fire Department came to the Brookwood Hills Board Meeting Monday, March 11, 1996 to respond to those questions. Present were Assistant Fire Chief William Ware, the officers in charge of the trucks which first arrived on the scene, and the Incident Commanders, Capt H.B. Dodson and Capt. Donald Zachary, who took over upon their arrival.

The first concern the officers

addressed was the response time to each of the fires. In the case of the O'Halloran fire at 41 Camden, the fire department records show that the dispatcher got the alarm at 6:06, and the first unit was on the scene at 6:11. Similarly, department records show that in the Hale's fire, the dispatcher received the call at 9:11 p.m.; trucks were dispatched at 9:12 and arrived on the scene at 9:17 Neighbors reported seeing a truck on Palisades searching for the fire. This was a second truck, responding to a call from a Palisades

neighbor who thought the smoke drifting from the Hale's fire was coming from a house on Palisades.


Calls to 911 are turned over to the fire department dispatcher. The firemen did not have the information as to what time the calls to 911 were received.

Neighbors attending the meeting asked why the firemen did not immediately spray water on the flames escaping from the roof of each house. Captain Dodson explained that shooting water on the fire from the outside produces steam and

gases that could endanger the lives of the firemen working on the inside. "Our strategy is to go to the inside to put the fire out," said Capt Dodson. "We try to put the fire out at the point of origin....We fought this fire very aggressively from the inside."

The first truck dispatched is a pumper truck which carries 500 gallons of water. In each of the two fires, hoses from this truck started pouring water inside the house immediately upon arrival at the scene. The natural gas lines to the house were also turned off upon arrival.

The Hale fire was an electrical fire caused by wiring in a Continued on page two

recessed light in the ceiling of an upper story bedroom. Firemen fought the fire from inside the attic. They also used pipe poles to expose the attic rafters through the bedroom ceilings. Firemen on ladders poured more water into the attic through these holes in the ceilings.

The O'Halloran fire began in the kitchen when food was left unattended on the stove. It spread quickly through the frame siding on the back of the house and then into the attic. The initial call to the station reported that flames could be seen coming up the back of the building. When the firemen reached the scene, the damage was already extensive. Their battle was made more difficult because heavy fire and smoke obscured the access to the attic.

Of concern to neighbors attending the meeting was the issue of whether there was enough water pressure. The firemen at the meeting stated that fire hydrants are checked in the fall and the spring. "There's no reason to be concerned," reassured Chief Ware. "You've got good pressure out here. We had to make adjustments to the dump valve to keep the valves from popping because of the pressure."

Residents were perplexed by the unhurried actions of firemen laying hoses in the streets at both fires. Capt. Dodson explained that these firemen were "laying off" the hoses: dropping them in the street and straightening them so there would be no impediment to the flow of water once the outside hoses took over.

Board member Elaine Moynihan asked what strategy the firemen used to protect neighboring houses. "Anything near a fire is called an 'exposure," explained Chief Ware. "We put men on a ladder with a hose on the left side of the Hale's house [to protect the Masseys' home], but this fire was burning up rather than out." Chief Ware pointed out that they were successful in saving other exposures, particularly the roofline of the new addition and the earlier addition the Hales had constructed several years ago. Damage was contained to the upper floors and roof of the original structure.

With fifteen months of renovation nearly completed, Anne and Bradley Hale were planning to move back into their home shortly. The house was completely empty of furniture and memorabilia, even in the attic. Ironically, fire detectors were set to be installed by the contractor the morning after the fire. Sheffield Hale stated at the Board meeting his parents' appreciation for the efforts of the firemen. "They have no criticisms whatsoever," said Sheffield.

Insurance Check

Liz Primm reminds us that if your house has not been rewired in the last five to ten years, you may need to add to your homeowner's insurance policy a special rider. The rider will require the insurance company to bring your home up to current code in the event of a disaster. Without the rider, the insurance company will only pay to restore the home to its condition immediately preceding the incident. Our older homes have hardwood floors and wooden lathing, which can be a dangerous combination with out-of-date wiring.

FREE SMOKE DETECTORS

As all of us know, the earlier a fire is detected, the easier it is to put out. The Atlanta Fire Department, Tandy Corporation (Radio Shack) and WXIA TV Channel 11 have joined together in an effort to give away 8,000 smoke detectors to low income and elderly citizens. If you know someone in need of a smoke detector (perhaps in the homes of maids, gardeners and babysitters), call 853-7069.

Board Supports Paris Market Variance


The owner of Paris Market, Bob Barnes, appealed to the Board of Directors on March 11 for support of his application for a variance to allow the Paris Market to have seating on its patio and inside the store. Zoning regulations currently prohibit any more restaurants with sitdown seating along the block of Peachtree between Palisades and Brighton due to the lack of available parking.

Mr. Barnes argued that his store would not contribute to the problem of spill-over parking in the neighborhood, which tends to be late at night on the weekends. He claimed that his gourmet take-out was largely a day-time business, aimed at people who live and work in the neighborhood. He offered to sign stipulations and conditions to the variance which would limit the number of seats requested and the hours of operation, and would require Paris Market to remain primarily a gourmet take-out shop rather than a full-service restaurant.

Included within these conditions, drafted by our zoning chairman Nick Sears, would be a stipulation signed by Mr. Barnes's landlord James Cumming that the conditions to the variance are specific to Paris Market and that subsequent tenants must apply for a separate variance.

Mr. Barnes mentioned that many of his steady customers are residents of the neighborhood and that without the proposed seating for lunch customers he may have to close his business. The Board voted to support Mr. Barnes's application subject to the conditions drafted by Nick Sears. Those who would like to show their support for Paris Market should attend the NPU-E meeting at 7:00 p.m. April 3 at the midtown public library at Sixteenth Street and Peachtree, in the second floor auditorium.






