POOL OPENS MAY 23rd!

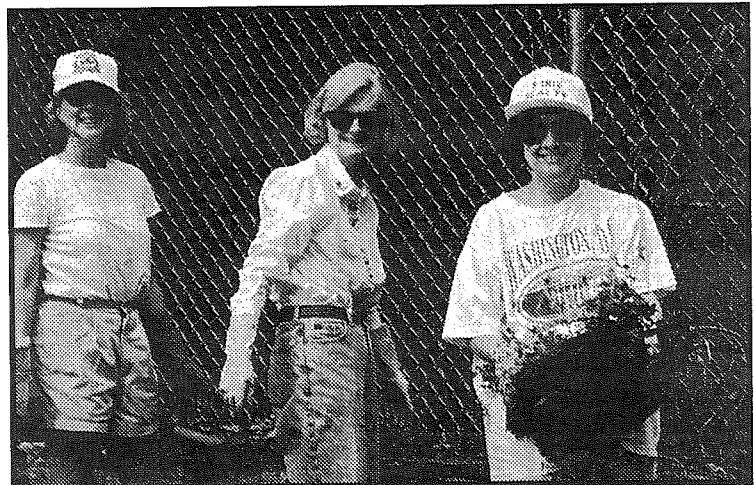

It's that time of year! The pool season begins Saturday, May 23rd at 12 noon. Our new manager is Brian Rooks. Chad Cook returns as head swim coach. A few reminders about the pool rules:

- No children under 10 years at the pool without an adult unless tested by the current pool manager. Only rising 3rd graders and above qualify to be tested. An emergency form and test must be completed annually.
- No floating baby boards. Guards need to see the pool bottom and these boards block too much of their view.
- Swim diapers must be on all non-potty trained children and children prone to accidents. (No poop in the pool please)
- Observe the city posted parking signs around the pool. Streets must be clear enough at all times to enable emergency vehicles access to the pool and neighboring homes (neighborhood members please *walk* to the pool!!)

Please take time to enjoy the new second diving board and additional dining tables on the upper deck. And, let's all remember to be patient with the new staff and management for the first week or so. They are all eager to do a great job for us, but need time to learn their duties and our special Brookwood ways. Have a great summer at the pool.

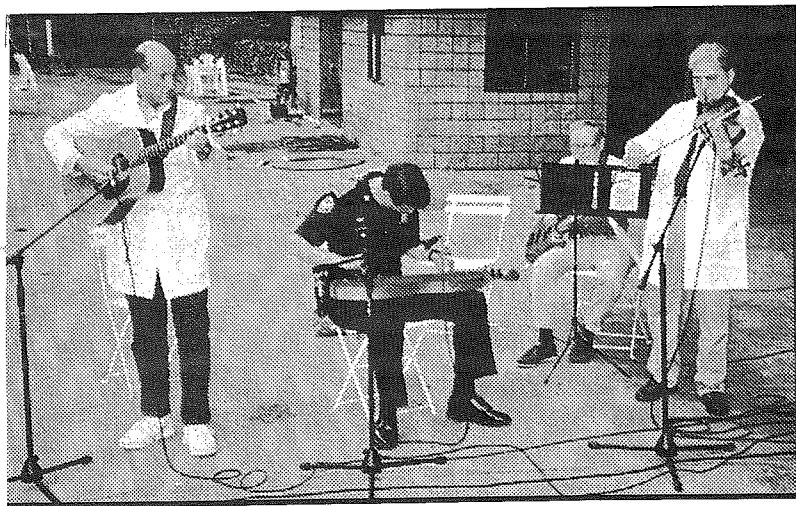

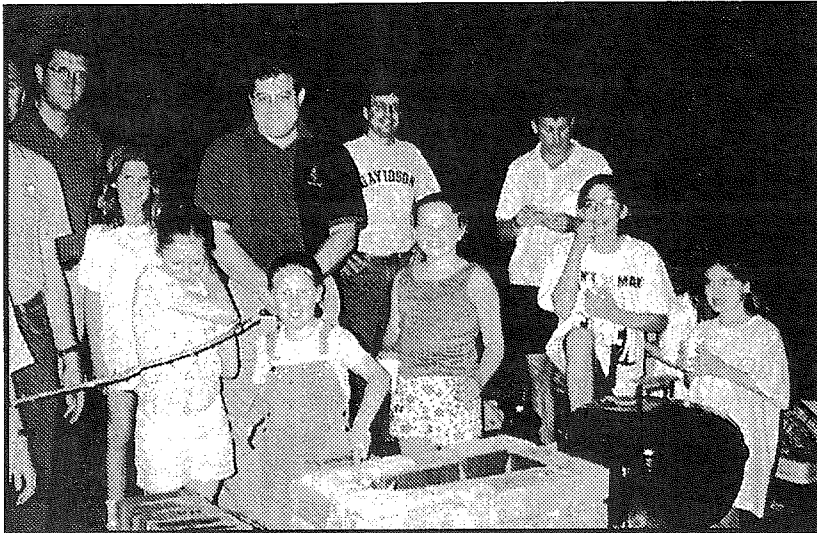
Atlanta Journal-Constitution columnist Furman Bisher wrote a wonderful article about Frank and his accomplishment on Thursday, May 7th.

PLANT AND REPLANT

Within a few weeks, residents of Brookwood Hills will again have the opportunity to request a tree for their front yard or sidewalk green space. These trees will be planted this fall. Funding for their purchase will be provided by the Brookwood Hills Garden Club and the Brookwood Hills Community Club.

The Tree Committee has compiled a wish list of sites we would like to plant trees. Committee members will be contacting homeowners in June. However, any resident is welcome to request a tree. There will be a specific list of large and medium tree options to go in yards or in green spaces where there are no conflicting wires. For the latter sites, smaller trees are available.

We will be using the same nursery and landscape company to provide the trees as last year - Bold Springs Nurseries and Gunn Landscaping. These companies did a great job for us during the first planting and we are sure they will again.

As many of you know from the article in Brooknotes, Arbor Day Partners selected Brookwood Hills Neighborhood to receive their "We believe in Trees Award." The tree committee is dedicated to continuing to the effort to support Atlanta's Urban Forest. In an April 1998 Atlanta Constitution article, Joe Burgess Georgia Forestry Commission's senior forester stated "The best way to avoid cutting down trees is to plant them strategically."

As part of the study of our trees, Arborguard recommended an ongoing maintenance program. This program includes the removal of hazardous trees, fertilization of healthy trees and a continuous replanting effort. The 1997 Fall Tree Offering resulted in the planting of 48 new trees in city green space and in neighborhood yards. Let's keep up the good work and plant as many as we can during the 1998 Fall Tree Offering. Please call Katrina Newton at 404-355-6574 if you would like a tree or if you have any questions.

BROOKWOOD BOYS END YEAR

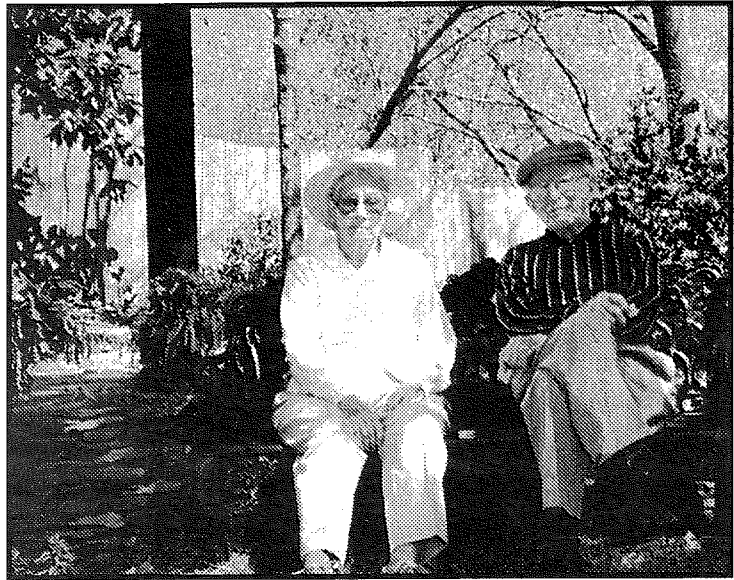

POOL REGULATIONS**

For POOL MANAGER or EMERGENCY CALLS, use pool phone: 351-0327

POOL HOURS

1. Pool hours will be posted at the concession stand. No persons except pool employees shall be allowed in the pool area at any time when the pool is not open. In the event of rain the pool may be closed at the discretion of the Pool Manager.

CONCESSION STAND HOURS

2. Concession stand hours will be posted at the concession stand. No Persons except members of the concession stand shall be premitted in the concession stand.

GUESTS

3. Use of the pool and other facilities of the club is reserved exclusively for "A", "C", and "D" members of the Club and their families. Guests will be permitted only when accompanied by an "A", "C", or "D" member, being registered by said member, and by payment of the appropriate guest fee. Members are responsible for explaining pool rules to their guests. Pool guest fees are as follows:
 - a. All guests of "A", "C", and "D" members will be charged \$2.00 per person on Monday through Thursday and \$3.00 per person on Friday through Sunday and holidays.
 - b. In-town guests of "A", "C", and "D" members are limited to a total of three guest visits per year. A member bringing more than three in-town guests at one time must obtain prior approval by the Pool Manager.
 - c. Members who have long-term houseguests (one week or more) should consult with the Pool Manager to purchase a visitor's pass.
 - d. Any planned function (party) shall be reserved with the Pool Manager no later than 7 days prior to the event and subject to the approval of the Pool Manager. No function may exceed 25 (member and/or nonmember) unless approved by the Pool Manager. A fee of \$25.00 on weekdays and \$35.00 on weekends will be charged, payable by check in advance, in addition to the per person fee described in item 3a. The per person fee is due upon arrival of the party.
4. The Club reserves the right to refuse admittance to the Club's facilities to any person.

CONDUCT

5. There shall be no running, no boisterous conduct, no rowdy or unruly behavior, no horseplay, no vandalism, and no destruction or damage to pool property. Parents shall be held responsible for the conduct of their children. The right of the members, their families, and guests to enjoy the pool facilities without being subjected to any loud or boisterous conduct whatsoever will be strictly enforced by the pool staff.
6. Only one person shall use or be on the diving board or ladder thereto or its braces at any one time. Swimming shall not be allowed under or to the side or in close proximity to the diving board due to the hazard of being struck by the diver. Divers should immediately exit the diving well by either ladder. Divers must not leave the diving board before the previous diver has reached the pool ladder.
7. The Pool Manager and the pool and concession stand staff, acting under his or her direction, shall be responsible for the enforcement of all rules and regulations. They shall be authorized to provide punishment for violation of these regulations and, except for gross abuse of their authority, their decision shall be final. Punishment shall include, but not be limited to, a warning, the policing of an area, temporary deprivation of use of pool facilities, or temporary expulsion from the pool premises. Permanent expulsion for repeated violators shall be at the sole discretion of the Board of Directors.

YOUNG CHILDREN

8. Except as provided in rule 9, children under 10 years of age and all nonswimmers must be accompanied by an adult while in the pool or immediate pool area.
9. Children who are rising third graders through rising fifth graders will be permitted to swim alone for a reasonable period of time, if they pass a swimming proficiency test incorporating American Red Cross advanced beginner skills. Passing will be judged by the Pool Manager or one of the assistants. An emergency information card and a release form must be filled out by a parent of each child and will be kept on file. Parents are reminded that the pool does not operate as a day care center for younger children.
10. Parents must accompany toddlers and small children in the water. No disposable diapers are permitted in the pool. All non-potty trained children must wear a swim diaper under their swimsuit. Certain specific swimming aids for toddlers and small children will be permitted in the shallow end. These aids should either be built into a swimsuit or of the vested innertube type. No plastic inflatable swim aids will be allowed, including water wings. No floating baby boards will be allowed.
11. Inner tubes, floats, Styrofoam boards, sand filled diving sticks, and squirt toys of any size or shape, will not be permitted in the pool. Kickboards are to be used in the lanes for lap swimming only.
12. The rope marker setting off the shallow end is a guide to help the lifeguards spot younger children who might wander into deeper water. Swimmers crossing the rope for any reason distract the guard. Do not cross the rope, climb or play on the rope. Children who cannot swim are not permitted beyond the rope unless accompanied by an adult. The shallow end is reserved for nonswimmers.
13. Skateboards, roller skates, rollerblades, tricycles, and bicycles will not be permitted anywhere in the pool, tennis, or concession stand area. Please use the park for these sports.
14. Tennis balls, baseballs, and other balls of similar size will not be permitted in the pool. Beachballs are the only type of ball permitted, but if the pool is crowded, the lifeguards may, at their discretion, limit or forbid the presence of beachballs in the pool. Throwing any type of ball in the pool or pool area is strictly prohibited.

FACILITIES

15. No food of any type may be carried to any point on the lower pool level or consumed there. Eating shall be restricted to the patios behind the wrought iron fence and covered snack bar area. All paper, food, cigarettes, and litter of every type and variety shall be placed in proper receptacles; therefore, under no circumstances shall any such litter be thrown upon the ground, into the pool, or on the Club property. On leaving eating tables, please put trash into receptacles. Paper cups and other paper objects may not be used as toys in the pool. No drinking glasses, bottles, glass containers, or anything of a similar nature shall be allowed on pool premises. Smoking is confined to the eating areas only.
16. Parents shall encourage their children to help keep the restroom tidy. All trash and paper shall be placed in the receptacles provided there. Persons should towel dry before going from the pool into the restrooms.
17. Tables are furnished for the convenience of members for eating and are not to be reserved or used for storage of pocketbooks, clothing, rackets, towels, shoes, etc. Unaccompanied personal belongings may be moved to the stone retaining walls by persons desiring to use such tables. Please be considerate of others and use the tables in this manner.
18. The back gate is for service use and should be used only for this purpose. It is distracting to the lifeguards to have children running back and forth to the park through this gate. (Handicap Exception Please Note: The back gate may be used as a handicap access if requested by a member or guest. Please contact the Pool Manager should this access be necessary.)

19. No furniture shall be placed on top of the concession stand building, except benches with wooden runners.
20. No dragging of furniture is allowed.
21. Fulton County Health Department requests that all swimmers shower before entering the pool.

PARKING

22. Bicycles shall not be left at any place other than the yellow area reserved for their use directly in front of the pool entrance. Bicycles shall not be left on the sidewalks surrounding the pool or against the fence or inside the pool premises under any circumstances. No automobiles shall be parked either in the area reserved for the parking of bicycles or in the park area without permission of the Pool Manager.

STAFF

23. The lifeguards' primary duty is to watch over the safety of persons using the facilities, and their attention to their duty should not be distracted by any person. Please **do not** loiter around the lifeguard stands or carry on unnecessary conversations with the lifeguards on duty. Lifeguards **are not** allowed to baby sit at any time while on their shift. They **are not** to be responsible for younger siblings unless the child passes requirements stated previously in rule #9.
24. Only employees shall be permitted behind the concession stand counter.
25. Violations of the above rules or complaints concerning the operation of the pool should be directed to the Pool Manager or his or her duly designated assistants, one of whom shall be on the premises at all times when the pool is open. Any failure of the pool or concession stand employees to perform their duties efficiently and politely should be reported to the Pool Manager, or the Pool Co-chairpersons, whose names are posted at the Pool.

PARK RULES

The Brookwood Hills Park is owned and maintained by the Brookwood Hills Community Club, Inc. for the use and enjoyment of its members and their guests. Please respect the following rules as to use of the Park. Members may schedule the Park for team practices and private parties according to the following guidelines.

General Rules

1. Members and guests should make appropriate use of the Park Play Areas and respect the boundaries of the natural spaces. Persons abusing Park property may lose Park privileges.
2. Young Children should be supervised at all times. Older children should be instructed in the proper use of the Park. The Community Club is not liable for injuries resulting from the use or misuse of Park space or equipment.
3. No glass bottles are permitted in the Park.
4. No motorized vehicles **of any kind** are permitted in the Park or in any other properties owned by the Community Club. (An exception is made for necessary pool and Park service vehicles.)
5. Dogs in the park must be kept on a leash and under the control of the owner at all times. Owners are responsible for the cleanup of any waste left in the Park by their pet.
6. Members and guests are encouraged to park their cars only on the side of the street bordering the park.
7. The Park closes at 10:00 P.M.

Parties and Special Events

1. All parties and special events must be scheduled at least one week in advance with the Park Chairman. He or she has discretion as to the number of parties or events which may be scheduled, after giving due consideration to preserving the Park for the general enjoyment of Community Club members and limiting disturbance to surrounding neighbors. The Reserving Member shall sign and return to the Park Chairman at least 24 hours prior to the party or special event a Consent Form stating the number of expected guests and a consent to the Park rules. Consent Forms shall be available at the pool mailbox at 77 Wakefield Drive.
2. There will be a general limit of 35 attendees per party or special event (exclusive of parents for children's parties). There is no use fee for parties of this size. Prior approval of the Board of Directors must be obtained for any party with over 35 attendees. The Board will assess a use fee, based on number of guests, for parties larger than 35 attendees. The fee scale will be determined by the Board, with a minimum fee of \$100. The Board has the discretion to waive the use fee for parties or special events held for the benefit of the neighborhood or for charitable organizations.
3. No live music or amplified music without prior approval of the Board of Directors.
4. Without prior approval of the Board, parties and special events must end by 9:30 P.M. to allow for clean-up before Park closure. The Park must be vacated by 10:00 P.M.

5. Special requests to the Board regarding party size, time extension, and use of live or amplified music must be submitted for Board approval prior to a regularly scheduled Board meeting.
6. The Reserving Member must be a member in good standing of the Community Club. He or she is responsible for ensuring that all guests conform to Community Club rules.
7. The Reserving Member must be present at all times during the course of the party or special event.
8. Trash must be hauled off-site by the Reserving Member. A failure to conform to this provision of the guidelines will result in a penalty of \$50.
9. If alcohol is to be served on Park premises, the Reserving Member shall sign a waiver holding the Brookwood Hills Community Club harmless from liability for all damages to persons or property resulting from alcohol use.
10. The Park Chairman or the President of the Community Club shall have the right to discontinue any party or special event that he or she deems too disruptive to the neighbors or otherwise in violation of Park Rules.
11. The Reserving Member shall make an effort to minimize disruption to the neighbors bordering the Park.

Athletic Practices

The playing field is available on a limited basis for children's sports practices. Coaches shall submit a Request Form for use of the field to the Park Chairman, listing the names of children of Community Club members and a consent to abide by Park rules. Request Forms shall be available in the pool mailbox at 77 Wakefield Drive. Teams must have at least one Member Parent who is in good standing with the Brookwood Hills Community Club. Priority shall be given to teams with the most Community Club members.

1. Saturday afternoon is reserved for free play. No team practice time is available.
2. Team practices shall be limited to one per day, Monday through Thursday. Two teams may schedule practices on Saturday mornings and Sundays.
3. For safety concerns, baseball practices are limited to T-ball and Rookie leagues.
4. A Member Parent must be present at all practices. He or she is responsible for ensuring that all Park rules are observed and that trash is placed in the receptacles.

BROOKWOOD HILLS COMMUNITY CLUB, INC.
TENNIS REGULATIONS

1. Members can reserve courts beginning at 6:00 A.M. on the day preceding the desired day of play to the times of the year when the pool is closed and the sign-up boards are kept outside. Reservations may be made beginning at 9:00 A.M. when the pool is open and the boards are kept in the concession stand.
2. Sign-up boards indicate time periods for play. Members may sign for themselves or immediate family only. Players signed for a court who are unable to play must have their names removed at least two hours before the period in order to give others a chance to reserve the court. Violators of this regulation will have their names posted. Persistent violators will be subject to additional penalties. Parents are responsible for their children's reservations.
3. When the pool is open, all players must sign in at the concession stand prior to entering the courts to allow better monitoring of rule adherence and court usage. During this time of year there will be a \$5 (five dollar) fee for guests payable at the concession stand.
4. Court reservations are valid up to 15 minutes beyond the commencement of the reserved time period, following which the reservation will be forfeited.
5. Children under 18 years of age should not sign up and must yield the courts at any time on weekends or holidays and after 5:00 on weekdays, except when playing with adult members. Children under 18 holding full-time summer jobs may sign up on week nights. When the pool is closed, children have preference in signing up at 3:30.
6. Food should not be taken on the courts. All paper cups and other litter must be removed and disposed of by players when leaving the court area.
7. All children who are not actually playing tennis are barred from the court enclosure to prevent distractions to players.
8. Courts may be used only with tennis shoes (or barefoot). Vehicles such as bicycles and skateboards are strictly prohibited. Rollerblades are also prohibited.
9. A player should not play more than one period a day as part of a sign-up group except as an emergency "fill-in" for doubles. Players, or groups of players, must vacate the courts after one period if others are waiting to play. Players may, however, use unreserved or unclaimed courts in addition to the periods signed for, whether the periods be consecutive or not.
10. Players who are able to take advantage of daytime periods during the week are especially encouraged to do so and leave night and weekend periods to those not able to participate at other times.
11. Players are strongly urged to turn off the lights on completing night play when there are not reservations posted for either court in the period immediately following. The economical use of lighting has become an important aspect of the club's tennis activities.
12. In situations not covered above, the spirit and general intent of these regulations govern - namely, the tennis courts should be available to as many players as possible, and practices which tend to restrict court use should be discouraged.
13. Currently constituted and participating ALTA teams shall have priority with respect to use of the Brookwood courts for the next ALTA season unless there is a newly constituted team having a larger number of Brookwood members than the old team. The team in existence for the longest continuous time shall have priority. However, if a new team is formed, the team captain or team mother must notify the Brookwood Tennis Chairman not later than January 5 for the Spring ALTA league and not later than June 1 for the Fall ALTA league, and if the newly formed team has more Brookwood members (according to current membership roster) than an old team, then the newly formed team shall replace the older team. These rules shall apply to all ALTA teams. Teams are encouraged to use as many Brookwood members as possible and to keep the use of non-members to a minimum. If an existing ALTA team does not wish to play in the immediately succeeding season, the team captain or team mother should notify the Brookwood Tennis Chairman as soon as possible. Otherwise it will be assumed that each team plans to play in the immediately succeeding season. Under current ALTA rules, all girls' matches are played on Tuesdays and all boys matches are played on Wednesdays. Thus, since we have only two courts, we are limited to two boys teams and two girls teams. Members are reminded that the courts are for the use of all members. ALTA teams may use the courts for practices of Mondays and Thursdays until 5:00 P.M. There are to be no ALTA practices on the courts on holidays or weekends.
