

A Message from the President

I would like to start this message by thanking Steve McCollam and Hayes Wilson for their hard work ensuring a happy and safe season around the pool this summer. Their job as pool co-chairmen is an enormous responsibility, and they did an excellent job. In the next few weeks, we will begin the process of renegotiating our contract with Swim Atlanta and making preparations for next year's season.

Thanks go out also to Sarah Hagood for sponsoring the Halloween party at the park, and to Diane John and Lauren Monroe for organizing it. The candy, costumes and activities were wonderful. My son Jay started talking about Halloween at the beginning of September. For him, and for so many other children in the neighborhood, Halloween ranks right up there with Christmas and birthdays in the major celebration category. Community focused acts like Sarah's sponsorship of the party are what make Brookwood Hills such a special place.

The work of the board continues. A brief summary is as follows:

<u>Traffic Plan</u>: As most of you know from the last issue of Brooknotes, the traffic plan was voted down by the neighborhood. While the decision was clearly the choice of the majority, there are many in the neighborhood who are disappointed, including me. I am disappointed because so many people have expressed a desire to feel safer in the neighborhood. As the father of two small children, I have often felt the same way. We want to feel safer, and yet there appear to be very few, if any, traffic calming measures that are acceptable both to a majority of the residents in the neighborhood and to the City of Atlanta, which has the ultimate decision making authority with respect to our streets.

The board will continue to look for acceptable ways to address the problem. As noted in your ballot materials, the City approved an all-way stop at the intersection of Brighton and Wakefield owing to sight-distance problems regardless of the outcome of the vote, and the board will move forward on that stop. We plan to approach the City about revisiting our request for additional stop signs, as they appear to be the most acceptable traffic calming measure from the neighborhood's standpoint. I would discourage you, however, from

having any expectation that board will find an alternative plan. The Long-Range Planning Committee and the Traffic Planning Committee, the members of which I want to thank for their endless hours of work, have made an exhaustive review of traffic calming alternatives. At this point, there do not appear to be any other measures that are both acceptable and effective.

I will finish with a plea to everyone in the neighborhood to slow down. Don't just drive the speed limit: drive five mph slower than the speed limit! Talk to your neighbors and ask them to slow down. Talk to the young drivers in your family and tell them to slow down, or else. Talk to your yardmen, domestic

workers, and contractors, and tell them to slow down. If you see a delivery truck speeding in the neighborhood, get the truck's number, note the time and date, and then call the company and report it. Awareness will also help.

<u>Camden/New Camden Lot Subdivision</u>: We have engaged a lawyer and an engineer to support us in opposing the subdivision of the lot at the intersection of Camden and New Camden. While this will be an expen-

sive undertaking for the Club, we are concerned that any new construction on this site could have significant negative effects on residents in the immediate area and down stream on Clear Creek. It is our understanding that these negative effects would be the result of the addition of impervious surface to the lot, the moving of soil for construction of a driveway and foundation, the diversion of flood waters, the cutting of several mature trees, etc.

I would encourage each of you to communicate your position on this issue to Mr. Robert Gray and Mr. James Bailey of the Bureau of Planning, City of Atlanta, 55 Trinity Ave., Suite 3350, Atlanta, GA 30335.

Peachtree Creek Sewer Intercept Project: Our discussions with the City over this project continue. We hope to be able to influence the design and implementation of the project in such a way that it minimizes the negative impact on the property and its surroundings, especially middle and lower Camden. Although we have no guarantees from them, Norm Copeland and Dave Peters of the Department of Public Works have indicated a willingness to entertain several changes, including modifying the course of the line and the location of the staging area. We also hope to increase the proposed compensation for the easement and to receive compensation for the installation of a security fence. We plan to take every necessary step to protect the trees on the property (including forcing the City to comply with its own tree ordinance) in order to minimize the number of trees that are cut and in order to receive appropriate compensation for any trees that must be cut. As you can imagine, this is also a very expensive proposition for the Club. We believe, however, that it is in everyone's best interest. BWH resident Dan Bromstad is the point person on this effort, if you have any questions.

Variance Requests: We have had several variance requests over the last few months. This frequently is a painful process for homeowners; it is time consuming and often controversial. It is the board's responsibility to review all variance requests in Brookwood Hills and to recommend to the NPU and the BZA that those committees either approve or deny a variance request. The board has a committee -- the Architectural Review Committee ("ARC") -- that reviews all requests before they are presented to the board. If you are contemplating alterations to your home, please determine early in the process if a variance is necessary (the zoning restrictions are listed on the City of Atlanta's website under City Ordinances, and there are links from the brookwoodhills.com website). If a variance is necessary, call the Zoning Chairman, Leigh Furrh, to schedule a meeting with the ARC and the board as soon as possible (you will also need to get on the schedules of the Urban Design Commission, the NPU, and the BZA to line up all your approvals). Discuss your plans with your immediate neighbors on all sides. Ask your neighbors to sign a letter indicating their support of your plan and bring this letter to your meetings with the ARC and board. If a neighbor does not support you, inform them of the dates on which it will be reviewed by the ARC and the board and explain that they will have an opportunity to express their concerns at those meetings. Opposition by a neighbor does not necessarily mean that the board will recommend denial of the request. However, the board will defer consideration of a variance request until all the immediate neighbors have been given an opportunity to review and react to the plans. A neighbor's support of the plan should be in writing. We are in the process of finishing a brochure that gives you more details on the approval process, and we will distribute it to everyone once it is finished.

Next Year's Board: We are in the process of putting together next year's board. If you are interested in working on the board or if you know of someone who is, please contact Pamela Watson, VP/President-elect.

Today Brookwood Hills is practically at the heart of metro-Atlanta, but when the development began in 1920, it was a suburban neighborhood. The curving streets follow the natural contours of the land and provide a beautiful tree lined setting for houses in a range of Revival styles by some of Atlanta's most prominent 20th Century architectural firms. Many of the homes in Brookwood Hills are listed in the National Register of Historic Places, and most of the neighborhood is designated as a Conservation District by the City of Atlanta.

The \$11,007 will benefit the Atlanta Preservation Center, a not-for-profit membership-based organization, which promotes the preservation of Atlanta's historically, architecturally and culturally significant buildings, neighborhoods and landscapes.
