#### **BWH Rejects Traffic Plan**

In late September, the Brookwood Hills board mailed a proposed traffic-calming plan and background package to each household in BWH. By a vote of 161 to 106, Brookwood Hills residents have rejected that plan. The 106 votes in favor of the plan constitute only 40 percent of total votes received, and 31 percent of all households eligible to vote, well below the 50 percent absolute majority required before the board would institute the plan. In fact, 47 percent of all eligible voters have specifically rejected the plan.

More decisively, the plan did not garner the necessary number of votes on Brighton and Huntington Roads needed to satisfy the City's 75 percent majority requirement. Specifically, Huntington households split 24 to 24, with 23 households not voting, while Brighton households rejected the plan 41 to 24, with 5 households not voting. In other words, 34 percent of Huntington and 59 percent of Brighton rejected the plan.

There were 141 surveys returned with the ballots, and the survey contents are revealing. After discussing various traffic-calming devices at several board and neighborhood meetings, the board of directors had anticipated that the flat-top speed humps included in the plan would be controversial, and indeed 82 respondents (58 percent of total respondents) noted that they did not favor speed humps or speed tables as a traffic-calming device. More surprising was the number of respondents who voted against traffic circles: 73 respondents (52 percent) objected to traffic circles as dangerous (because they confuse drivers about right-of-way and their landscaping blocks visibility), expensive, and difficult for emergency vehicles to maneuver.

All-way stop signs received the most substantial support among respondents: 109 (77 percent) wrote that they would favor all-way stops as a traffic-calming device. Unfortunately, the City thus far has refused to allow BWH to put in all-way stops unless they are combined with other, less popular, traffic-calming devices. The City's traffic engineers explain that all-way stops can actually be dangerous, first because drivers do not expect stop signs on thoroughfares and consequently tend to run them, and second, because stop signs on thoroughfares often frustrate drivers, who consequently increase their speed between stops.

While less popular than stop signs, textured and painted crosswalks were acceptable to the majority of respondents. Ninety respondents (64 percent) supported the neighborhood's use of textured crosswalks, and 81 (57 percent) supported the use of painted crosswalks. A number of respondents also wrote comments advocating strict enforcement of Brookwood Hill's 25 MPH speed limit. The neighborhood, however, has been told that there is no stretch of road in Brookwood Hills long enough and straight enough to use radar.

The board of directors would like to thank everyone for voting and for taking the time to respond to the survey.

## 435 Camden Road Applies for Permission to Subdivide

An application has been made to the City of Atlanta to subdivide the property at 435 Camden Road located at the corner of Middle and New Camden. Clear Creek runs along the rear of the property. At present, the neighborhood has decided to oppose the application, primarily because the property lies within the 100-year flood plain. Given that Clear Creek historically floods, this property, as well as adjacent properties, are subject to flooding. The construction of another dwelling would exacerbate an already unstable situation. The City of Atlanta currently is under a consent decree to bring itself into compliance with the Clean Water Act. Under this consent decree, the City cannot continue with a known action that will exacerbate existing problems, such as storm water runoff, soil erosion, pollution, and flooding.

#### Update: Impact of Peachtree Creek Interceptor Sewer Project on Brookwood Hills

Since the last issue of the Brooknotes, the Brookwood Hills Community Club Board of Directors has retained an attorney, Don Stack, in addition to our engineering consultant, Alan Blake. Don and Alan are assisting us in working with the City to minimize the impact of the new sewer line segment on our Clear Creek property. We met with Lee Morris, our City Councilman, and he arranged a meeting with Dave Peters, the Deputy Director of the Department of Public Works and the project team on October 10, 2000.

Dave Peters made a commitment at the meeting to evaluate four alternatives that would avoid many of the pitfalls of the current design. He also agreed to include our engineer in all surveys, site inspections and discussions related to the evaluation process. We have scheduled a followup meeting with the same group for November 1, 2000 to discuss next steps.

The Brookwood Hills Community Club has hired a water-engineering firm to evaluate the effects that the proposed subdivision and development of 435 Camden would likely have on the surrounding properties, including land owned by the Community Club. The neighborhood is of the opinion that the addition of another driveway and house on this property will require cutting, filling, and moving of soil, cutting of trees, and the construction of retaining walls, all of which may aggravate an already problematic situation visa-vis the Clean Water Act.
